LAND PRESERVATION

- 416-acre Chase Tract: Saved as farmland and Ramanessin section of Holmdel Park
- 97-acre DePalma Farm: Saved as farmland
- 20-acre Mahoras Greenway Nature Area
- 103-acre F&F Nurseries: Saved as farmland and part of Ramanessin Brook Greenway
- 12.5-acre Del Tufo tract: Extension to Labbe Park
- 11-acre Neil Waackaack Nature Preserve
- Prevented sale of 12-acre portion of Cross Farm Park

WATERSHED PROTECTION

- Streams feeding Swimming River Reservoir granted Category 1 (C1) protection
- Prevented extension of development-inducing sewer lines into southern Holmdel
- Helped block commercial sports complex on Main Street (Rte. 520)
- Thwarted installation of toxic synthetic turf fields at Cross Farm Park

NEIGHBORHOOD ACTIVISM

- Limited Route 35 Big Box stores
- Prevented Palmer Avenue apartment building construction in flood-prone area
- Led resident fight against NJNG for major gas regulator complex on Holmdel Road
- Supported activist campaign against high power transmission lines along train tracks
- Continued monitoring of affordable housing impacts

COMMUNITY OUTREACH

- Originator and annual sponsor of Earth Day Festival at Bayonet Farm
- Host of educational presentations and public forums
- Creator and distributor of YouTube posts of local government meetings
- Organizer/host of Design Charette that guided redevelopment of Bell Labs, now Bell Works
